### NAM

The full name of the organisation shall be "Federatia Romana de Cricket" with the trade name of "Cricket Romania".

# SECTION

# 2

## BROAD SCOPE AND

The scope and objectives of Federatia Romana de Cricket, hereinafter called FRC/Cricket Romania have been laid out in the "Statut" (being the Articles & Memorandum of Association). Additionally, FRC's management will be guided and driven by this Internal Rules and Regulations (hereinafter referred to as IRR) and its tasks/responsibilities will be as follows:

To be responsible for the development and growth of cricket in Romania within the parameters of the International Cricket Council (ICC) and the requirements of the Ministry of Youth and Sports

ii) To establish a National Development Plan as defined by ICC Membership Criteria to be reviewed and renewed on an annual basis with the development programme being reflected in the Annual Budget of FRC

iii)

Following the formation of the Federation, Cricket

Romania will continue to support the Federation in promoting cricket in Romania, though given the scope and opportunity that might arise, Cricket Romania or its subsidiaries or affiliates, can enhance its geographical spread to further cricket per se in the Central and Eastern European region.

iv) Until the formation of the FRC, all matters of cricket and all cricket related activities in Romania previously undertaken by Fundatia -Consilul Romana de Cricket with regard to cricketing issues are now taken over by FRC who are responsible for all aspects of the management, regulation and authorisation of the game; participating and setting up of competitions internally within Romania, between schools and legally established clubs and management and selection of the team(s) representing Romania for visits by teams representing foreign countries or visits to foreign countries.

vi) The other key objective of the FRC is to ensure that the game of cricket is conducted in the Spirit of Cricket at all times and that prompt and remedial action is taken at any point it feels or is so reported, that such Spirit is not being adhered to by its Members or associates. Towards this end FRC will issue a Code of Conduct as defined by ICC but with appropriate amendments to relate to the local environment.

# SCOPUL SI OBIECTIVELE

Domeniul de aplicare si obiectivele Cricket Romania au fost prevazute in "Actul Constitutiv" si "Statutul Fundatiei" (fiind mentionate ca Articolele si Memorandumul de Asociere). In plus, managementul Cricket Romania va fi ghidat si condus de acest Regulament Intern si Reglementari (denumita in continuare "RIR") si sarcinile/ responsabilitatile sale vor fi dupa cum urmeaza:

i) A intreprinde toate actiunile necesare pentru a deveni un membru afiliat al Consiliul International de Cricket (denumit in continuare "CIC") si a atinge acest obiectiv pana in Decembrie 2012.

ii) A stabili un Plan National de Dezvoltare in concordanta cu criteriile de aderare definite de ICC, ce va fi revizuit si reinnoit anual si Programul de Dezvoltare ce se va reflecta in bugetul anual al Cricket Romania (a se vedea articolul 10)

iii) A participa si a depune toate diligentele in vederea infiintarii Federatiei Romane de Cricket. La formarea sa, sa predea Federatiei unele dintre activitatatile cheie ce sunt efectuate, in conformitate cu Constitutia Federatiei si a legilor corespunzatoare din Romania.

iv) Dupa formarea Federatiei, Cricket Romania va continua sa sprijine Federatia in promovarea cricketului in Romania, avand in vedere domeniul de aplicare si posibilitatea ce ar putea aparea, Cricket Romania, filialele sau subsidiarele, pot creste raspansarea sa geografica in regiunea Europei Centrale si de Est.

v) Pana la formarea Federatiei, Cricket Romania va fi custode pentru toate aspectele de cricket si toate activitatatile legate de cricket in Romania - si va fi responsabil pentru toate aspectele legate de gestionarea, reglementarea si autorizarea jocului; participant, precum si organizand competitii la nivel intern, in Romania, intre scoli si cluburi si gestiunea si selectia echipei(lor) ce reprezinta Romania pentru vizite ale echipelor reprezentand tari straine sau vizite in tari straine.

vi) Un alt obiectiv-cheie al Cricket Romania in colaborare cu Federatia Romana de Cricket, atunci cand aceasta va fi fondata, va fi de a se asigura ca jocul de cricket se desfasoara in Spiritul Jocului in orice moment si ca o actiune prompta si de remediere este luata in orice moment este necesar sau este raportata, deoarece Spiritul Jocului de Cricket nu este respectat de membri sau asociati sai. In acest scop Cricket Romania va elabora un Cod de Conduita in concordanta cu reglementarile ICC, dar cu amenda- mentele necesare pentru a se reporta la mediul local.

# INTERPRETATION / DEFINITIONS

## CLUBS

Any club, which has been legally established and as required by the rules of the Ministry of Youth and Sport and which has 'cricket' listed as an activity in their statutes may be affiliated to FRC.

## COMMISSIONS

Commissions as defined in the "Statut" will be appointed by the Council of Directors at their quarterly meetings and reviewed annually as to the status of their membership and effectiveness

## ICC

ICC refers to the International Cricket Council.

## MEMBERS

Members shall be those Clubs as defined above and have been approved for affiliation to the FRC

## OFFICIALS

Any person appointed by the Board or the

Commissions in an honorary or paid position

## PLAYERS

Players shall mean any cricketer who is registered with a Member (see Article 8 (iii)(a)).

## SPIRIT OF CRICKET / GAME

The Spirit of Cricket or Spirit of the Game is as defined in The Preamble to the Laws of Cricket published by MCC (Marylebone Cricket Club) in England. (Annexure1).

Additionally if any act that causes or may seem to cause harm, damage or bring disrepute to cricket in Romania or cricket per se will be defined as being contrary to the Spirit of Cricket/ Game.

Where possible, the conduct of Members, Office Bearers and those associated with cricket in Romania, will be defined in the Code of Conduct as referred to in Section 2.

# INTERPRETARE / DEFINITII

### CLUBURI

Orice club, care a fost infiintat in temeiul legislatiei romanesti si care fie joaca si/sau promoveaza cricket-ul ca o parte semnificativa a activitatii sale.

### COMISIA PENTRU DISCIPLINA IN CRICKET

Aceasta Comisie va fi numita de catre Consiliul Director, dupa obtinerea aprobarii unanime a Consiliului de Administratie. Comisia va fi alcatuita din 3 persoane. Membrii vor detine aceasta pozitie pentru o perioada de un an, moment in care procesul de numire va fi realizat din nou. Un membru ales anterior poate fi reînnoit cu conditia ca el sau ea sa nu detina pozitia mai mult de 3 ani consecutiv.

### FUNDATIA

Orice trimitere la Fundatia Consiliul Roman de Cricket va insemana "Cricket Romania"

### MEMBRII FONDATORI

Membrii Fondatori sunt cei care au sustinut ideea initiala de Cricket Romania si au promovato pentru a conduce si a coordona dezvoltarea cricket-ului in Romania. Acesteia nu sunt alesi si isi pastreaza pozitia pe viata.

### CIC

CIC se refera la Consiliul International de Cricket

### INSTITUTIA

Orice organism cu personalitate juridica cu sediul in Romania care intr-o forma sau alta

este implicat in jocul sau sprijinirea cricket-ului si astfel de activitati formeaza o parte importanta a operatiunilor sale; astfel de organisme pot fi scoli, colegii si corporatii. Trimitera la Institutie va include elevii, angajatii sau furnizorii lor traditionali care sunt implicați in jocul de cricket.

## MEMBRII

Membrii sunt acele cluburi sau institutii care sunt infiintate in conformitate cu legea romana si unde cricket-ul este fie cea mai mare parte sau cea mai importanta dintre activitatile sale, dupa caz; cei ce au solicitat si au fost acceptati ca membri ai Cricket Romania dupa cum au fost votati de catre Membrii Fondatori. Cluburi sau institutii, de asemenea, se refera la/sau inseamna membrii — afiliati care joaca sau nu, studenti, angajati sau jucatori traditionali.

## FUNCTIONARII

Orice persoana numita de catre Consiliul de Administratie intr-o pozitie de onoare sau platita in Cricket Romania, va fi numit pe durata mandatului ca fiind Oficial.

## JUCATORII

Prin jucatorii se intlege orice jucator de cricket care este inregistrat ca Membru (a se vedea Articol 8 (iii)(a)).

## SPIRIT JOCULUI DE CRICKET

Spiritul Jocului de cricket sau Spiritul Jocului este cel definit in Preambulul Legilor de Cricket publicate de catre MCC (Marylebone Cricket Club) in Anglia (Anexa 1). In plus, in cazul in care orice act care provoaca sau poate cauza prejudicii, daune sau aduce dezonoare cricketului in Romania sau cricket-ului in sine va fi definita ca fiind in contra-dictie cu Spiritul Jocului de Cricket/Spiritul Jocului.

Acolo unde este posibil, comportamentul membrilor, Oficialilor si a celor asociati cricket-ului in Romania, va fi definit in Codul de Conduita, mai sus mentionat in Sectiunea 2.

# T I O N

## THE BOARD

The Board of will be made up of some or all of the Founding Members. The Board has the option to include additionally 2 Members selected on a rotational basis for a period of one year. The Board will be responsible for the overall management of Cricket Romania as empowered by the "Actul Constitutiv" and "Statutul Fundatiei".

## THE CHIEF EXECUTIVE OFFICER (CEO)

The CEO (erstwhile designation of Executive Secretary) will be a position selected by the Board and will be responsible for conducting the day to day operations of Cricket Romania as empowered by the Board and Steering Committee.

## THE PRESIDENT

The President of the Steering Committee will be elected from the Founding Members by the Board for a period of 4 years. The outgoing President may offer himself for re-election as many times as he/she wishes.

## THE STEERING COMMITTEE

The Steering Committee will be made up of at least of the President, CEO, the Treasurer and he Techni- cal Director. The Committee may co-opt a Board Member to participate in its functioning if and when it so requires. The Steering Committee shall be empowered by the Board to arrange and transact the affairs of Cricket Romania, and to deal with any matter arising in connection with the achievement of the Objectives.

## THE TREASURER

The Treasurer will be selected by the Board and will primarily be responsible for the financial operations of Cricket Romania along with the CEO.

Consiliul de Administratie al Cricket Romania va fi format din cativa sau toti Membrii Fondatori. Consiliul de Administratie are posibilitatea de a include, in plus

2 Membri selectati pe baza de rotatie pentru o perioada de un an. Consiliul va fi responsabil pentru gestionarea globala a Cricket Romania, imputernicit prin "Actul Constitutiv" si "Statutul Fundatitiei".

### DIRECTORUL EXECUTIV

(ChiefExecutiveOfficer) CEO-ul (denumirea veche de "secretar executiv") va fi o pozitie desemnata de catre Consiliul de Administratie si va fi responsabil pentru efectuarea operatiunilor de zi cu zi ale Cricket Romania ca imputernicit de catre Consiliul de Administratie si Consiliul Director.

### PRESEDINTELE

Presedintele Consiliului Director al Cricket Romania va fi ales din Membrii Fondatori de catre Consiliul de Administratie pentru o perioada de 4 ani. Presedintele poate candida pentru realegere ori de cate ori doreste.

### CONSIGIUL DIRECTOR

Consiliul Director va fi alcatait din cel putin Presedinte, CEO, Trezorier si Director Tehnic. Consiliul poate coopta un membru al Consiliului

de Administratie pentru a participa la functionarea acestuia in cazul in care si atunci cand situatia o cere. Consiliul Director este abilitat de catre Consiliul de Administratie pentru a organiza si efectua tranzactiile de afaceri pentru Cricket Romania, si pentru a aborda orice chestiune rezultata in legatura cu realizarea obiectivelor.

### TREZORIERUL

Trezorierul va fi selectat de catre Consiliul de Administratie si va fi in principal responsabil pentru operatiunile financiare ale Cricket Romania, impreuna cu CEO-ul.

- i) i) The logo of Cricket Romania shall be as set out in Annexure 2 and the colours and fonts of the logo shall be as defined in this Annexure.
- ii) This logo will be registered in Romania and internationally with OSIM (Oficiul de Stat pentru Inventii si Marcii).
- iii) Cricket Romania asserts its full rights to the aforementioned logo, and colours, and the wearing of such by Members, players or guests shall be a privilege granted exclusively by Cricket Romania, and not a guaranteed as a right to anybody.

# 5

## FUNCTIONS OF THE

i) In addition to its Interpretation and constitution as described in Article 3 above, the Board may co-opt any individual to the Board for a period of a year if such a person has in his or her individual capacity contributed significantly to the development of cricket in Romania.

Such an appointment shall be unanimously agreed by at least all the Founding Members.

ii) The primary function of the Board is to approve issues proposed and put forward by the Steering Committee. The Board may turn down such proposal or recommend changes to the Steering Committee to consider. It may also put forward alternative or new proposals as and when it may find it appropriate to do so. The approvals or otherwise from the Board, may be obtained at its quarterly meetings or electronically should timings so demand, under a collective email to all Founding Members. Responses from the Members should also be copied to all the relevant addressees.

## FUNCTIILE CONSILIU- LUI DE ADMINISTRATIE

i) In plus la Interpretare si constituire asa cum este descris in Articolul 3 de mai sus, Consiliul de Administratie poate coopta orice persoana in Consiliu pentru o perioada de un an in cazul in care o astfel de persoana are capacitatea de a contribuit semnificativ la dezvoltarea cricket- ului in Romania. O astfel de numire trebuie sa fie convenita in unanimitate de catre cel putin toti Membrii Fondatori.

ii) Functia principala a Consiliului de Administratie este de a aproba probleme propuse si prezentate de catre Comsiliul Director. Consiliul de Administratie poate refuza astfel de propuneri sau poate recomanda modificari Consiliului Director pentru a le lua in considerare. El poate, de asemenea, transmite alternative sau noi propuneri dupa cum si cand considera ca este oportun sa se faca acest lucru. Aprobari sau altfel de decizii pot fi obtinute in cadrul reuniunilor sale trimestriale sau in format electronic daca se impune acest lucru,

In cadrul unui e-mail colectiv tuturor membrilor fondatori. Raspunsurile din partea membrilor ar trebui sa fie, de asemenea, copiate tuturor destinatarilor implicați.

# FUNCTIONS OF THE STEERING COMMITTEE

i) In addition to this IRR and without prejudice to the generality of powers conferred directly or by necessary implications under the "Actul Constitutiv" and "Statutul Fundatitiei", the Steering Committee shall perform or where stated or required, delegate the performance of the following duties, bearing in mind the requirement of the Boards approval as stated in Article 5 (ii) above as applicable.

Romania and for the development of cricket in Romania.

(a) To arrange, conduct and manage all domestic cricket competitions in Romania, at any level, under the auspices of the ICC (where applicable) and corresponding laws of Romania.

(b) To arrange, conduct and manage all international competitions, at any level, involving the Romanian national teams either domestically or abroad, under the auspices of the ICC (where applicable) and corresponding laws of Romania.

(c) In consultation with the Board, to write up and publish the Rules for the games to be played whereby they would deviate from the Laws of Cricket and to be responsible for updating these rules and ensuring their adherence by all participants.

(d) To recommend bye laws/changes to IRR for the management of Cricket Romania provided the requirements as stated under Rule 9(i) - Quorum have been complied with.

(e) To collect funds and fees for the exclusive purpose of meeting the objectives of Cricket

(f) To appoint a representative from its members or from the Board, to be the point of interaction and contact with ICC and other international bodies as applicable till the formation of the Federation.

(g) To appoint a representative to represent Cricket Romania in the international forum.

(h) To appoint managers and other officials for the Romanian cricket teams.

(i) To supervise, conduct and manage the Coaches, Umpires, Scorers and Curators activities, so that they can achieve the required levels as defined by the ICC and/or as required by other international

standards.

(j) For international competitive matches involving the Romanian team, to appoint delegate Umpires and Scorers.

(k) To appoint the Selection Committee to be made up of 3 persons, at least one of whom will be a Board member, the Captain (see Article 6(l) below) and one other person who must be a Member. However care to be taken to ensure that in appointing the Selection Committee, the majority are not members of the same club. The Selection Committee will be in place for the duration of the event or time it has been appointed for. Should the Board unanimously deem it fit, the \_\_\_\_\_ members of the Selection Committee may be changed if found necessary.

# FUNCTIILE CONSILIULUI DIRECTOR

i) In plus fata de acest Regulament Intern si Reglementari si fara a aduce atingere caracterului general al competentelor conferite In mod direct sau prin implicatiile necesare, In conformitate cu Actul Constitutiv si Statutul Fundatitei, Comitetul Director va efectua sau In cazul In care este nec- esar, delega exercitarea functiilor urmatoare, tinand seama de cerinta de a avea acordul Consiliului de Admnistratie astfel cum este mentionat In Articolul 5 (ii) de mai sus, dupa caz.

- Cvorum-ul a fost respectat.

(e) Pentru a colecta fonduri si taxele exclusiv in scopul atingerii obiectivelor Cricket Romania si pentru dezvoltarea cricket-ului din Romania.

(a) Pentru a organiza, conduce si gestiona toate competitiile nationale de cricket in Romania, la orice nivel, sub auspiciile CIC (dupa caz) si legile corespunzatoare din Romania.

(b) Pentru a organiza, conduce si gestiona toate competitiile internationale, la orice nivel, care implica echipe romanesti nationale, fie din tara sau strainatare, sub auspiciile CIC (dupa caz) si legile corespunzatoare din Romania.

(c) In consultare cu Consiliul de Administratie pentru a scrie si publica Regulile pentru jocurile ce vor fi jucate in cazul in care s-ar abate de la Legile Cricket-ului si de a fi—responsabil pentru actu- alizarea, acestor reguli si de a asigura respectarea acestora de catre toti participantii.

(d) Sa faca legi/ si modificari la RIR pentru ges- tionarea Cricket Romania cu conditia respectarii cerintelor asa cum se mentioneaza in Articolul 9(i)

(f) Pentru a desemna un reprezentant dintrumembrii sau din Consiliul de Administratie, pentru a fi punctul de interactiune si de contact cu CIC si alte organisme internationale, dupa caz, pana la formarea Federatiei.

(g) Sa desemneze un reprezentant care sa reprezinte Romania in forum-ul international.

(h) De a numi manageri si alti oficiali pentru echipele de cricket romanesti.

(i) De a supraveghea, conduce si gestiona activitatea antrenorilor, arbitrilor, scorerilor si curatorilor, astfel incat acestea sa poate atinge nivelurile cerute astfel cum sunt definite de catre CIC si/ sau in conformitate cu alte standarde internationale.

(j) De a numi/ delega arbitri si scoreri pentru meciurile internationale ce implica echipa romaneasca.

(k) De a numi Comisia de Selectie ce va fi alcatauita din 3 persoane, cel putin unul dintre ei va fi un membru al Consiliului de Administratie, Capitanul (a se vedea articolul 6(l) de mai jos) si o alta persoana ce trebuie sa fie un Membru. Cu toate acestea trebuie luate masuri pentru a se asigura ca, in numirea Consiliului de Selectie, majoritatea nu sunt membri ai aceluiasi club.

Consiliul de Selectie va fi in functie pe durata evenimentului sau in timpul pentru care a fost numit. In cazul in care in unanimitate Consiliul considera ca este necesar, membrii Consiliului de Selectie pot fi schimbuti daca este necesar.

# FUNCTIONS OF THE STEERING COMMITTEE

(l) To appoint a Captain and Vice-Captain for the national cricket team for the cricket season; these appointments will be for a maximum period of 12 months. The Captain and or Vice-Captain may be reappointed for the next season. However should the situation demand, and if recommended by the Board, the Captain or Vice-Captain may be changed any time during the 12 month tenure. The Steering Committee may however if required, make such appointments for a tournament, competition or defined period not exceeding 12 months only.

(m) To review any breach, contravention or infringement of the rules and regulations of cricket or the Laws of cricket by any of its officials or Members and take appropriate action against the person or body concerned or any of its incumbents. In this respect the Commission of Cricket Discipline will be set up and appointed and supervised by the Board, its incumbents holding positions as defined in the interpretations above.

(n) Generally to do all such other acts and things as may appear to the Steering Committee to be expedient, convenient and/or conducive to carry out the objectives of Cricket Romania.

# FUNCTIILE CONSILIULUI DIRECTOR

(l) De a numi un Capitan si Vice-capitanu pentru echipa nationala de cricket pentru sezonul de cricket; aceste numiri vor fi pentru o perioada de maxim 12 luni. Capitanul si/ sau Vice-capitanul poate fi reinnoit pentru sezonul urmator. Cu toate acestea daca situatia o cere, dupa cum s-a decis printr-o decizie unanima a Consiliului de Administratie, capitanul sau vice-capitanul pot fi revocati din fuctie in orice moment in timpul mandatului de 12 luni. Consiliul Director poate, cu toate acestea, daca este necesar, sa faca numiri pentru un turneu, concurs sau perioada definita de maximum 12 luni.

(m) Sa revizuiasca orice incalcare sau contraventie a normelor si reglementarilor de cricket sau a Legilor Cricket-ului de catre oricare dintre oficialii sau membrii sai si ia masurile corespunzatoare impotriva persoanei sau organismului in cauza sau oricare dintre furnizorii traditionali ai acestuia. In acest sens, Comisia pentru Disciplina in Cricket va fi creata, numita si supravegheata de catre Consiliul de Administratie, furnizorii traditionali astfel cum sunt definiti in interpretarile de mai sus.

(n) In general, pentru a face toate acte si alte lucruri care pot aparea in fata Consiliului Director a fi eficiente, convenabile si/sau sa conduca la realizarea obiectivelor Cricket Romania.

# CONDUCT OF OFFICIALS, MEMBER AND ASSOCIATES

Cricket Romania prides itself in upholding the Spirit of Cricket as embodied in the Laws and as implied within the concept of the term.

As such, Cricket Romania expects its, officials, Members and its players, employees and their incumbents, to conduct themselves both on and off the pitch, in a manner consistent with the Spirit and traditions of the game and as further defined in the Code of Conduct. Complaints concerning the conduct of Members shall be dealt with by the Commission

for Cricket Discipline as set up by the Steering Committee in 6(i)(m) above. Conduct injurious to the good name, character or interests of the Cricket Romania or Romanian cricket, can render the Member liable to expulsion.

Unless otherwise defined in any applicable section elsewhere in the IRR, any Member, who is the subject of such an allegation, shall have the right to attend the hearing of the Commission for Cricket Discipline, at

which the complaint is heard, and to speak in his own defense.

The decision of the Commission for Cricket Discipline in this regard shall be final.

sedinta Comisiei pentru Disciplina in Cricket, la care se va asculta plangerea, si sa vorbeasca in apararea sa.

Decizia Comisiei pentru Disciplina in Cricket in aceasta privinta va fi definitiva.

# MEMBERSHIP / AFFILIATION

Until such time as the Federation is formed, Clubs and Institutions, may apply for affiliation/mem- ber- ship to Cricket Romania, (application form for membership is detailed in Appendix 5) where after with the formation of the Federation their member- ship may be transferred there. In the meantime members will be guided by the IRR of Cricket Romania as applicable within this document and specifically as detailed hereunder.

### (i) MEMBERSHIP STATEMENT

Clubs and Institutions that are elected as Members of Cricket Romania, will be required to sign a Af- filiation Agreement (Annexure 3) where they agree to comply with the IRR, uphold the Spirit of Cricket and adherence to the Laws of Cricket and project a positive image of cricket and Romania at all times.

### (ii) MEMBERSHIP FEES

On being elected, Members will be required to pay an annual membership fee by the end of January of each year. The amount of the fee will be determined by the Steering Committee and approved by the Board annually and the amount advised to all concerned as required. Members, who have failed to pay their fees by the due date, will not be permitted to participate in any competition organised by Cricket Romania, permitted to avail of any of the benefits that members have, nor vote in any meeting till such time the fees are paid in full.

### (iii) REGISTERING MEMBER DETAILS

(a) Clubs who have been selected as Members,

must register and record details of each of their playing and non-playing members (minimum information as

detailed in (Annexure 4) and afford each such member with a unique membership number. Such information of each member must be registered with Cricket Romania. A complete list of members should be sent as at the end of each calendar quarter irrespective of changes. In the event of changes, these should be advised at month end.

Monthly /quarterly reports

should be sent to Cricket Romania by the 5th day of the following month.

(b) Institutions who have been selected as Members, must register and record details of each of their students or paid employees who are connected with the cricketing activity in question, affording each such student or paid employee an unique institutional number. Such information of each such student or paid employee must be registered with Cricket Romania. Up dates/changes to this list must be advised on a monthly basis thereafter to the Cricket Romania.

(c) TRANSFER POLICY

Playing Member's of Affiliated Clubs wishing to leave the membership of that club (referred to as the 'Source Club') and join another Affiliated club (referred to as the 'Destination Club'), must complete the Transfer Application Form 1.11 (Annexure 6) and submit the completed form any time between 1st January and 28th February each year. A second transfer period

will be available from 1st June to 30th June.

The Member must complete Part 1 of the form (TAF 1.11) and submit it along with Part 2 and 3 to the Source Club. An Authorised Committee member of the Source Club will fill in Part 2, sign and stamp the form and forward it to the President / Secretary of the Destination Club. The Destination Club will fill in, complete sign and stamp part 3 of the TAF and forward the completed application to CRC.

On receipt of all three completed parts of the TAF, CRC will review the case and confirm the transfer to both the Source and Destination clubs. CRC will only withhold its approval to the transfer in the event it is of the opinion that this transfer will be detrimental to the game of cricket in Romania or to either of the clubs concerned. Incomplete applications or applications received after the 'transfer window' will not be entertained and the applicant in question will have to reapply at the time of the next 'transfer window.'

# MEMBRU / AFILIERE

Pana in momentul in care Federatia este formata, Cluburile si Institutiiile pot aplica pentru aderare la Cricket Romania, (formularul de cerere pentru statut de membru este detaliat in Anexa 5), aderarea lor putand fi transferata la Federatie dupa formarea acesteia. Intre timp membri vor fi ghidati de "Regulament Intern si Reglementari" (RIR) a Cricket Romania, dupa caz, in acest document si in mod specific dupa cum este precizat in cele ce urmeaza.

### (i) DECLARATIE DE MEMBRU

Cluburile si Institutiiile ce sunt alese ca membri ai Cricket Romania, vor trebui sa semneze un Acord de Afilierea (Anexa 3) unde vor preciza ca sunt de acord sa se conformeze RIR, vor sustine Spiritul Jocului de cricket, vor respecta Legile Cricket-ului si vor proiecta o imagine pozitiva a cricket-ului si a Romaniei in orice moment.

### (ii) COTIZATIILE DE MEMBRU

Dupa ce au fost alesi, Membrii vor trebui sa plateasca o taxa anuala de membru pana la sfarsitul lunii ianuarie al fiecarui an. Cuantumul taxei va fi stabilit anual de catre Consiliul Director si aprobat de Consiliul de Administratie, iar suma anuntata tuturor celor implicati, dupa caz. ### (iii) INREGISTRAREA DETALIILOR MEMBRILOR

(a) Cluburile ce au fost selectate in calitate de membrii, trebuie sa se inregistreze si sa inscrie detalii fiecarui membru ce joaca sau nu cricket (minimul de informatii sunt detaliate in Anexa 4) si sa atribuie fiecarui membru un numar unic. Astfel de informatii ale fiecarui membru trebuie sa fie inregistrate la Cricket Romania. Lista completa a membrilor trebuie trimisa la sfarsitul fiecarui trimestru indiferent de modificari. In cazul unor modificarilor care aceasta lista trebuie trimisa la sfarsitul fiecarei luni. Rapoartele lunare/ trimestriale trebuie sa fie trimise

catre Cricket Romania pana in a 5-a zi a lunii urmatoare.

(b) Institutiile ce au fost selectate in calitate de membri, trebuie sa se inregistreze si sa inscrie detaliile fiecaruia dintre elevii sau salariatii ce au legatura directa cu activitatea de cricket in cauza, atribuind astfel fiecarui elev sau salariat un numar unic de inregistrare. Astfel de informatii ale fiecarui elev sau salariat trebuie sa fie in- registrate la Cricket Romania. Actualizările/ modificările listei trebuie sa fie trimise lunar catre Cricket Romania.

(c) POLITICA DE TRANSFER

Jucatorii activi ai cluburilor afiliate care doresc sa re- nunte la calitatea de membrii ai acestor cluburi (denu- mite in continuare "Clubul Sursa") si sa adere la un alt club afiliat (denumit in continuare "Clubul de Desti- natie") trebuie sa completeze Formularul - Cerere de Transfer 1.11 (Anexa 6) si sa depuna formularul comple- tat, in orice moment, intre 1 Ianuarie si 28 Februarie in fiecare an. O a doua fereastra de transfer este deschisa incepand cu 1 Iunie pana la 30 Iunie.

Membrii trebuie sa completeze Partea 1 a Formularului

- Cerere de Transfer (FCT 1.11) si sa il depuna impreuna cu Partea 2 si 3 la "Clubul Sursa". Un membru autorizat al comitetului din "Clubul Sursa" va completa Partea 2, va semna si stampila formularul si il va trimite mai departe Presedintelui/Secretarului "Clubului de Desti- natie". "Clubul de Destinatie" va completa in totalitate, va semna si stampila Partea 3 a FTC si il va trimite catre CRC.

La primirea celor trei parti completate ale FTC, CRC va evalua cazul si va confirma transferul "Clubului Sursa" si "Clubului de Destnatie". CRC va opri transferul numai in cazul in care considera ca acest transfer va fi in detrimentul jocului de cricket in Romania sau pentru oricare dintre cluburile in cauza. # MEMBERSHIP / AFFILIATION

In the event CRC withholds its approval, or the transfer request falls outside the window dates, this does not prevent the Member from making the transfer. However in such cases he / she cannot represent the (Destination) club in any formal competitive games conducted by the CRC or ICC as the case may be until such time as the transfer is approved by CRC.

(d) The requirements under 8(iii) must be strictly followed to allow Cricket Romania to ensure that no person is playing for more than one Club or Institution in a competition as required by ICC.

## (iv) COLTS / JUNIOR CRICKET

Members must actively promote the development of cricket for a Colts (under 15) section. This may be done in two ways – first by introducing Cricket Romania to appropriate schools where cricket in the form of Kwik Cricket may be introduced (see the relevant section of Development Programme) and, secondly, by inviting talented students to additional coaching programmes conducted under the auspices of the club themselves. Where the concerned student has reached the required skill levels of playing the hard ball form of the game, given the adherence to ICC rulings on the matter, the student should be encouraged to actively participate in the regular fixtures and games of the Member. Where appropriate, Cricket Romania will assist and support the Member with its coaching programmes. Within a period of 3 years of its formation, a Member Club should have developed a Colts section which would be playing regular games and holding coaching programmes.

## (v) WOMENS CRICKET

Members must actively promote the development of women's cricket by inviting women to coaching programmes run by the club to learn the basics of the game and in time to establish a women's section. Given that it is likely that in the initial stages not enough women may be available to form a separate section, clubs who include women in their team that participate in a competitive game conducted by Cricket Romania, will be entitled to subsidies as defined by the Steering Committee for each case.

## (vi) GROUNDS AND FACILITIES

Members are responsible for and must establish their playing grounds and related facilities as soon as possible so as to ensure that practice and matches can be undertaken and played on a regular basis. Where ever possible, Cricket Romania will assist and support in development of the facility.

## (vii) REPRESENTATION

Members in defining their own seasonal fixture list must ensure that they are representing themselves only and not representing or pretending to represent any other entity either domestic or international.

## (viii) SPONSORS & SPONSORSHIP

Members should actively develop their own local sponsorship to assist with the finances of running of the club. Where ever possible, Cricket Romania will provide assistance with development of cricket in the form of financial or material support.

(ix) MEDIA ACTIVITY & RIGHTS

Cricket Romania will supervise and manage all matters related to domestic and international media exposure relating to itself and of all its Members and Affiliates.

#### (vii) REPREZENTAREA

#### (viii) SPONSORI SI SPONSORIZARE

# MEMBERSHIP / AFFILIATION

With the formation of the Romanian Cricket Federation, the Federation accepts to give-away all its domestic and international media rights - in any and all forms, to Cricket Romania, in exchange for the free-of-charge usage of all of Cricket

Romania and its Members/Affiliates facilities, for the next 49 years. This contract of assignment will be signed by the parties following the formation and registration of the Romanian Cricket Federation.

Cricket Romania and its subsidiaries or associated company(ies) structures will have full exclusivity to and for the following:

(a) The rights on the individual and group image, either static or in motion of all its players, coaches, umpires and other related personnel in corresponding competition equipment, every time they participate in an event sponsored and/or organised by Cricket Romania either in the domestic or inter-national arena.

(b) The rights to use/display in anyway its logo's, pictures, or any media product related to competitions domestic or international sponsored or organised by Cricket Romania

(c) The rights of usage of the name of the competitions organised by Cricket Romania.

(d) The rights over all of the income generated by advertising in any form (written, TV or Radio broadcast), for all the competitions organised by Cricket Romania and for all the competitions

in which Cricket Romania Members/Affiliate teams (at any level) participate.

(e) The rights over income received from ICC where ICC have distributed funds to its participants for their events,



Cricket Romania Affiliates and Members have the following rights:

Affiliates and Members of Cricket Romania have the right to develop their own marketing and advertising material in accordance with their respective sponsorship agreements if applicable and retain

all such income which may be derived from it, provided such material and activities are related to their own club and not related to Cricket Romania. Where such exposure may involve Cricket Romania or any of its subsidiaries or associated bodies, it should be done with the prior written approval of Cricket Romania.

(x) MEMBER BENEFITS

Members will be entitled to the following

benefits: (a) Be eligible to participate in any competitions and/or tournaments organised by Cricket Romania whether under the auspices of ICC or otherwise, domestic and internationally

(b) Be eligible to put forward the names of their members for selection in matches to represent Romania in any game whether competitive or friendly at home or overseas.

(c) To use any of the Cricket Romania's ground, playing facilities or other related equipment at the discounted rate available to Members, of course based on availability.

(d) To get preference in applying for any courses and/or coaching session that Cricket Romania will hold from time to time and if selected, to benefit from paying the Member's discounted rate.

Membrii si Afiliati Cricket Romania au urmatoarele drepturi:

(e) To have access to the Cricket Romania's database of name and details of other playing clubs in Romania and the region

letterheads, website and other published material.

(f) To have benefit of the Cricket Romania's contacts in the world of cricket for information and advice on matters relating to cricket.

(g) To be entitled to receive in part, any funding and financial support that Cricket Romania may receive from ICC or other bodies in respect of development of the game. However receipt of such funds by the Member is not a right of the Member – the decision to give and the amount to be given will be the decision of Cricket Romania, which decision will be final and binding to all its Members.

(h) To be entitled to receive either pro-rata or by lottery, any tickets that Cricket Romania is allotted to any international cricketing fixtures.

(i) To be entitled to receive a share of any earnings received by Cricket Romania where Cricket Romania has the media rights for such revenues. However receipt of such funds by the Member is not a right of the Member – the decision to give and the amount to be given will be the decision of Cricket Romania, which decision will be final and binding to all its Members.

## (xi) CRICKET ROMANIA AFFILIATION

Members will be entitled to use the strap line – "Affiliated to Cricket Romania" on their

Such entitlement may also include the use of the Cricket Romania logo provided such usage conforms strictly to the design of the logo as detailed in Annexure 2 and/ or the Corporate Identity Manual as applicable.

(xii) MANAGEMENT & FIXTURE SCHEDULES OF MEMBER CLUBS

(a) Members will be responsible for their own management and fixture programmes. In scheduling their fixtures they should ensure as best as possible that these do not in any way clash with fixtures scheduled by Cricket Romania. While Cricket Romania will be keeping all Member Clubs advised as and when fixtures, competitions and programmes both nationally and internationally are scheduled, it would be prudent for Clubs to reconfirm dates with Cricket Romania before finalising their own fixtures. Members should take note of Article

8(ix) while scheduling their fixtures with overseas entities.

(b) Clubs will be required to advise Cricket Romania of matches which have been arranged by them as and when they are fixed, stating name and location of opponents. Post match, details of the match results with any photographs should be advised to Cricket Romania no later than 7 days from the completion of the match. Where matches are played under the auspices of Cricket Romania all media related materials remain the property of Cricket Romania as detailed in 8(ix) above.

(xiii) MEMBER'S FEES

Members, who have been removed from membership of Cricket Romania, shall not be entitled to refund of their annual fee.

materiale publicate. Dreptul poate include, de asemenea, utilizarea logo-ului Cricket Romania, o astfel de utilizare fiind strict conform cu modelul logo-ului asa cum este detaliat in Anexa 2 si/ sau in Manual de Identitate Corporate, dupa caz.

**(xii) MANAGEMENT-UL SI LISTELE CU  
MECIURILE CLUBURILOR MEMBRE**

(a) Membrii vor fi responsabili pentru managementul propriu si pentru programul meciurilor. In programarea meciurilor trebuie sa se asigure cat mai bine posibil ca acestea nu intra in conflict in nici un fel cu meciuri programate de Cricket Romania. In timp ce Cricket Romania va informa toate cluburile membre cu privire la programul meciurilor, competitiilor si programelor atat la nivel national cat si international, ar fi indicat ca si cluburile sa-si reconfirme datele cu Cricket Romania inainte de a finaliza propriile lor date de joc. Membrii ar trebui sa ia nota de Articolul 7(ix) in timp ce fac programarea meciurilor cu echipe internationale.

(b) Cluburile vor fi rugate sa aduca la cunostinta Cricket Romania meciurile ce au fost organizate de ei atunci cand acestea sunt stabilite, specificand numele si locatia adversarilor. Dupa incheierea meciului, sa furnizeze Cricket Romania detalii cu privire la rezultatele meciului cu orice fotografii, nu mai tarziu de 7 zile de la terminarea meciului. In cazul in care meciurile sunt jucate sub auspiciile Cricket Romania toate materiale multimedia legate de meci vor ramane in proprietatea Cricket Romania asa cum este detaliat in Articolul 7(ix) de mai sus.

**(xiii) TAXELE DE MEMBRU**  
Membrilor, ce l-au fost retrase calitatea de membrii ai Cricket Romania, nu vor avea dreptul la rambursarea restituirea taxei anuale ale acestora.

# MEMBERSHIP / AFFILIATION

## (xiv) QUOTA POLICY

Consilul Roman de Cricket's aim is to develop cricket in Romania primarily with Romanian players. With a view to further development of Romanian cricketers, with effect from 1st January 2012, it will be mandatory for clubs playing in internal, national or international competitions organised and arranged by CRC and national teams representing Romania in a competitive environment, to have a minimum number of "indigenous Romanians" (see definition below) playing (see definition below) in the team. Such numbers / quotas will be determined for the following year by CRC in the year preceding and will be increased each year till an optimum number is reached. The optimum number will be determined by the Board of CRC or the Federation when established.

This requirement will be in addition to any criteria defined by ICC, a host nation's rules or competition rules required to qualify as a "national team". Clubs failing to fulfil this requirement will be precluded from participating in that game in which the shortfall occurs and bear the consequences thereof. Further violations will, in addition to being precluded from the game, cause the offending club to be required to "show cause" to the CRC Commission for Cricket Discipline as to why the club should not be banned from playing for the rest of the season.

The penalty to be imposed for a second violation will be decided by the Commission for Cricket Discipline based on the findings at the hearings.

## DEFINITIONS

'INDIGENOUS ROMANIAN' means a person who is born in Romania and has Romanian nationality or if not born in Romania, has a Romanian passport and one of whose parents were born in Romania. In both cases the person concerned must be a resident of Romania. Naturalised Romanians are not considered as indigenous.

'PLAYING' means the players must be in the team of 11 players to take the field, at least one of whom must bat at number 8 or above or bowl a minimum of one over in the match or be the wicket keeper for at least

10 overs (or half the game if match is a reduced over match). In the event an innings is completed before the

7th batter has to bat or the scheduled number of overs is completed, then these requirements need not have to be met.

If an indigenous player on the fielding side leaves the field during the game, then the substitute must be another indigenous player or the side will field with less than 11 players till the player returns. Umpires may in extenuating circumstances, if required in consultation with the Match Referee, permit a substitution by a non-indigenous player.

The number of indigenous Romanians for 2013 will be "3 (three) indigenous Romanians" per competitive team of 11.

### (xiv) POLITICA DE COTA

Obiectivul Consiliului Roman de Cricket este sa dezvolte in primul rand cricketul in Romania cu jucatori romani.

In vederea dezvoltarii jucatorilor de cricket romani, incepand din 1 ianuarie 2012, este obligatoriu pentru cluburile care joaca in competitii interne, nationale sau internationale, organizate si coordonate de CRC si pentru echipele nationale ce reprezinta Romania intr-un cadru competititional, sa aiba un numar minim de "romani indigeni" (vezi definitia de mai jos) ce joaca (vezi definitia de mai jos) in echipa. Aceste numere/cote vor fi stabilite pentru anul urmator de catre CRC in anul precedent si vor fi majorate in fiecare an pana ce un numar optim este atins. Numarul optim va fi stabilit de catre Consiliul de Administratie sau de catre Federatie cand aceasta va fi infiintata.

Aceasta cerinta va fi suplimentara oricarui criteriu definit de ICC, a oricarei cerinte a unei natiuni gazda sau oricor reguli competitionale necesare pentru calificarea ca "echipa nationala". Cluburile vor fi excluse din jocul in care nu indeplinesc aceasta cerinta si vor suporta consecintele. Alte viitoare incalcari vor fi sanctionate, in afara de excluderea din joc, cu obligatia de a "demonstra motivul" pentru care clubul nu va fi exclus din urmatoarele meciuri din sezon in fata Comisiei pentru Disciplina in Cricket a CRC.

Pedeapsa aplicata pentru o a doua incalcare va fi decisa de catre Comisia pentru Disciplina in Cricket bazata pe constatarile din cadrul audierilor.

### DEFINITII

'ROMAN INDIGEN' inseamna o persoana nascuta in Romania care are nationalitate romana sau daca nu este nascuta in Romania, poseda pasaport romanesc si cei ai caror parinti sunt nascuti in Romania. In ambele cazuri persoana in cauza trebuie sa fie resident in Romania. Romanii naturalizati nu sunt considerati indigeni.

'A JUCA' inseamna ca jucatorul trebuie sa fie parte din echipa de 11 jucatori din teren, cel putin unul trebuie sa fie al 8-lea, sau mai putin, la bataie sau sa arunce mingea cel putin un over per meci sau cel putin 10 overuri ca wicket keeper (sau jumate de meci daca jocul este unul cu overuri reduse). In cazul in care un inning se incheie inainte de intrarea celui de al 7-lea batter sau numarul de overuri stabilit se incheie, atunci aceste cerinte nu trebuie sa fie inadecvurate.

Daca un jucator indigen, aflat pe teren in echipa de fielding, paraseste terenul in timpul meciului, cel care il inlocueste trebuie sa fie un alt jucator indigen sau echipa va avea mai putin de 11 jucatori la fielding pana cand jucatorul indigen se va intoarce pe teren. Arbitrii, in circumstante atenuante, consultandu-se cu Arbitrul Meciului daca este necesar, pot permite inlocuirea cu un jucator non indigen.

Numarul romanilor indigeni pentru anul 2013 este de "3 (trei) romani indigeni" per echipa concurenta de 11 jucatori.

# MEETING

## 9

### (i) THE BOARD

The Board will meet at least once a quarter or more often as and when there is a need to assemble a meeting or address a situation. This is in addition to the requirements of the "Actul Constitutiv" and "Statutul Fundatitei" (see below 9(iii))

Minutes.

Minutes of the meeting will be kept and—written and circulated to all members of the Board and their consent to the contents obtained and recorded.

#### Quorum

The quorum to hold the meeting will be 5 members (2/3rd of the number of Founding Members) and in the event the agenda requires the casting of votes – a simple majority of those present will pass the issues unless otherwise stated elsewhere in the IRR. In the event of a tie, the President of the Steering Committee's vote will be final. If the President is not present at a meeting, then one will be appointed for that meeting only by the Founding Member's present. Such a person can cast the 'final vote' as stated above if required.

However, if the issue requires a change of the IRR, then the approval of all Founding Members will be necessary to make the change. (Founding Member's consent may be obtained in writing or electronically by email if he is not able to be—present at the meeting).

### (ii) THE STEERING COMMITTEE

The Steering Committee will meet at least once a month to review the performance in terms of the budget, expenditure and progress with the National Development Programme. Decisions made will be by simple majority.

### (iii) THE ANNUAL GENERAL

#### MEETING OF THE BOARD

In accordance with the "Actul Constitutiv" and "Statutul Fundatitei", the Board members will meet to approve the budget, expenditure and programme and activities for the forthcoming year.

As such this meeting needs to be held no later than in the month of November.

### (iv) THE ANNUAL GENERAL

#### MEETING OF MEMBERS

An Annual General Meeting of all members will be held once a year, following the AGM of the Board to advise all members of the achievement and developments of the year in review and the programme for the year ahead.

(i) The accounts of Cricket Romania will be maintained in accordance with the Romanian fiscal laws and expressed in RON. However for management information purposes it will also be presented in Euro.

(ii) In addition to the requirements under Romanian law, the accounts must also follow International Accounting Standards so that review of consolidated and published financials will be acceptable to international bodies who may wish to review them.

(iii) In addition to the requirements of Romanian Law, the accounts of Cricket Romania will be annually audited by an international body of auditors who are appointed by the Steering Committee as approved by the Board and whose appointment will be done on an annual basis. The external Auditors may offer themselves for appointment each year but cannot be reappointed for more than 3 years consecutively.

(iv) Management Accounts must be presented at every quarterly Board meeting.

(v) Cricket Romania will maintain a bank account in the currencies of RON, Euro, Pounds Sterling and Dollars. The account will be operated by at least two persons, one of whom will be the Treasurer and one other person from the Steering Committee

While a webmaster will be appointed, the CEO will be responsible for the website and its contents.

# Annexure 1



## The Preamble - The Spirit of Cricket

Cricket is a game that owes much of its unique appeal to the fact that it should be played not only within its Laws but also within the Spirit of the Game. Any action which is seen to abuse this spirit causes injury to the game itself. The major responsibility for ensuring the spirit of fair play rests with the captains.

### 1. THERE ARE TWO LAWS WHICH PLACE RESPONSIBILITY FOR THE TEAM'S CONDUCT FIRMLY ON THE CAPTAIN. RESPONSIBILITY OF CAPTAINS

The captains are responsible at all times for ensuring that play is conducted within the Spirit of the Game as well as within the Laws.

#### PLAYER'S CONDUCT

In the event of a player failing to accept or act upon the decision of an umpire, the captain must bring the game into dispute with the other umpire and to the player's captain, and

bring the matter to the other umpire and to the player's captain, and

### 2. FAIR AND UNFAIR PLAY

According to the Laws the umpires are the sole judges of what is fair play. The umpires may intervene at any time and it is up to them to take action where required.

### 3. THE UMPIRES ARE AUTHORISED TO INTERVENE IN THESE CASES:

- Time wasting
- Damaging the pitch
- Dangerous or unfair bowling
- Tampering with the ball
- Any other action that they consider to be unfair

### 4. THE SPIRIT OF THE GAME INVOLVES RESPECT FOR:

- Your opponents
- Your own captain
- The roles of the umpires
- The game's traditional values

### 5. IT IS AGAINST THE SPIRIT OF THE GAME:

- To dispute an umpire's decision by word, action or gesture
- To direct abusive language towards an opponent or umpire
- To indulge in cheating or any sharp practice, for instance:
  - (a) to appeal knowing that the batsman is not out
  - (b) to advance towards an umpire in an aggressive manner when appealing
  - (c) to seek to distract an opponent either verbally or by harassment with persistent clapping or unnecessary noise under the guise of enthusiasm and motivation of one's own side

Captains and umpires together set the tone for the conduct of a cricket match. Every player is expected to make an important contribution towards this.


